First day of fumigation your house will be covered and chemicals will be applied. During the fumigation one window per room will be open between 3 and 6 inches. On the following working day aeration process will begin. On last day of fumigation tent will be removed and re-entry notice will be posted ob front door and gas meter \*\*DO NOT REMOVE POST UNTIL GAS COMPANY HAS ARRIVED. \*\*

Under no circumstances may anyone enter the structure until it has been declared safe for re-entry by a licensed fumigator. Anyone entering the structure prior to the re-entry time is violating the California Structural Pest Control Act. This is punishable by a fine of one thousand dollars, six months in jail, or both.

Although the fumigant has been aired from the structure, the warning agent may remain. If this occurs, open all windows for two or more hours. Running the heater may also help, as we have found that damp conditions may cause the warning agent to linger. Our after hours Medical Emergency Hot Line number is 818-515-2387

If you experience symptoms of dizziness, headache, nausea, reduced awareness, slowed movement, garbled speech or difficulty in breathing, leave the structure immediately and seek medical attention by contacting your physician or Poison Control Center and notify your termite company. The warning agent, Chloropicrin, can cause symptoms of tearing eyes, respiratory distress and vomiting. Entry into the structure during the FUMIGATION CAN BE FATAL.

IT IS THE RESPONSIBILITY OF THE HOME OWNER, OCCUPANT, OR HOME OWNER'S AGENT, TO HAVE ALL ITEMS ON THIS CHECKLIST DONE BEFORE THE CREW ARRIVES. IN CASE OF RAIN OR STRONG WINDS THE JOB MAY HAVE TO BE POSTPONED TO A LATER DATE. - Remove all people and pets (fish, birds, dogs and cats) from the house or yard. The water in the fish tank does not have to be drained, but turn the air pump off. Leave with the assurance that your building will be properly fumigated and will be safe for your return. Notify your neighbors who may have cats of the upcoming fumigation dates and close-off entry points in your property well in advance to prevent animals from entering the space. BE SURE AND LEAVE ANY EMERGENCY PHONE NUMBER WHERE YOU CAN BE REACHED. IF FORCEABLE ENTRY IS NECESSARY, THE FUMIGATOR WILL NOT BE RESPONSIBLE FOR REPAIRS.
- No one can enter the property for any reason before the property has been certified for a safe re-entry by a licensed fumigator once the property has been covered and the Vikane Gas has been released. Under no circumstances can anyone enter the building until the fumigation company's notice is posted for safe re-entry.
- All type of vehicles must be removed from driveways during fumigation. Remove vehicles from the garage/carport, if included. In case a vehicle is left in the garage, windows, trunk and glove compartment must be left open
- Remove all interior and exterior plants, whether potted or hanging in/on the building(s). Heavy plants/planters will not be moved by the

- 7. The occupant must soak the soil with water at least 12 inches from foundation outward. This can be done the evening before and may help to protect plant root growth. Cut back plant growth where possible 12 to 18 inches away from exterior of building(s), this includes ivy, vines and bougainvillea. If debris is not cleared away and vines and trees are not trimmed, the crew might not get a good ground seal with the tarps. Plants, vines, grass etc. that might be covered during fumigation might die. Climbing plants, fences, trellises and vines not detached from the building may be subject to damage. The fumigator will not be held liable. Water and electricity must be turned on during fumigation. All automatic devices (sprinklers, fixtures or other items) must be turned off. Next Generation Fumigation will not be responsible for damages to lightning fixtures and other items that project from the structure
- 8. The occupant **must turn off** any **air conditioning** units and heaters, thermostat operated or otherwise. If any burglar alarms are to be left on, leave instructions on operation; movement alarms must be turned off.
- 9. ACCESS IS REQUIRED BY LAW. We must have access to all areas within the structure, including rooms or garages kept locked. - 13. In cases where gas pilots will not remain lit after lighting, or where heater, water heater or oven are old, and special expertise is needed in lighting, we will request that you contact the gas company to come and relight the pilot.
- 14. 4. Our crews must furnigate several structures in various locations each day. We provide a call for every job. Each job presents its own unique challenges and our crews are also subject to traffic conditions, therefore, any time of day for the furnigation to be scheduled will be an approximate time only.
- 15. Fumigations require the use of masking tape. Where the painted surface is old, oxidized, or improperly applied, peeling or chipping will occur. Even though these surfaces appear to be in good condition we assume no responsibility for any damage.

In the interest of Douglas Products' commitment to product stewardship, this fact sheet is intended to provide basic information about the product and how it is used. If you have specific questions about your fumigation, refer to documents provided by the fumigator or call the fumigator listed on the warning signs posted on your structure. ### WHY BUILDINGS ARE FUMIGATED

Insects that feed or tunnel into wood can seriously damage houses, apartments, and other dwellings or structures. Each year termites or other wood destroying insects damage more than 5 million homes. Other pests, such as bed bugs, may be dispersed throughout rooms and can be difficult to locate and control quickly and completely. Depending on the extent or location of the infestation, fumigation is the only total control method proven to eliminate certain infestations of wood destroying insects, bed bugs, and other structure-infesting pests.

### HOW BUILDINGS ARE FUMIGATED

Because Vikane is a gas, prior to fumigation, the structure is completely sealed. This serves to contain Vikane in the building so it can penetrate wood and building contents to thoroughly eliminate the pests. Depending on the construction of the building, the doors and windows may be sealed with tape and a plastic sheet, or the structure may be covered with a tarp. The building will remain sealed for 2-72 hours depending on the specifics of the job. Warning signs are posted around the building notifying people to keep out.

After the fumigation period is completed, a professional

fumigator will aerate the structure using fans for a prescribed aeration period. Once the dwelling has been thoroughly aerated, the fumigator is required to measure the level of any fumigant remaining in the living space to ensure it is below the EPA approved concentration for reentry by the occupants. Extremely low levels of fumigant can remain for a short period of time in dead air spaces between walls and inside cabinets as well as porous materials such as furniture. The small amount of fumigant in these areas will continue to dissipate for a few hours after the fumigation but at levels well below the established safe reentry concentration. Your building will not be cleared for reoccupancy until it is safe to enter. The fumigator will post a notice on your building indicating the day and time for reentry. Structures can be occupied only when the concentration is 1 part per million or less (this represents a margin of safety – laboratory animals have been exposed to 100 parts per million for 2 weeks with no adverse effects). Because Vikane is a true gas and not a vapor, aeration is rapid. Recent studies demonstrated that in most structures levels are less than 1 part per million after the prescribed aeration period and have no detectable levels of Vikane within 24 hours after the start of aeration.

Sulfuryl fluoride is a colorless, odorless gas, so a warning agent is added to the building that causes watery eyes and a scratchy throat. If you experience these symptoms in a structure that has been recently fumigated, you should leave immediately and call the pest control company to have your building retested.

### SULFURYL FLUORIDE (POTENTIAL HEALTH RISKS FROM OVEREXPOSURE)

Sulfuryl fluoride is a gas that can potentially enter your body only through inhalation. Because it is a gas, it does not stay on dry surfaces; therefore, there is no exposure from touching treated surfaces.

### NERVOUS SYSTEM AND RESPIRATORY IRRITATION

Overexposure to high levels of sulfuryl fluoride can result in nose and throat irritation and nausea. At high concentrations (such as those used during the fumigation) it can cause excess fluid in the lungs, sleepiness, pneumonia, and convulsions. These symptoms would be expected to appear within 8 hours after such an exposure. In the unlikely event you experience these symptoms in the building that has been recently fumigated, you should leave immediately. Consult your physician and call the pest control company to have your building retested.

### **ADDITIONAL STUDIES**

Sulfuryl fluoride has not been shown to cause birth defects in pregnant animals exposed under experimental conditions. In addition, current studies have demonstrated there are not mutagenic or genotoxic effects caused by exposure to sulfuryl fluoride.

### **QUESTIONS**

If you have specific questions about your fumigation, refer to documents provided by the fumigator or call the fumigator listed on the warning signs posted on your structure. ## SAFETY PRECAUTIONS AND HOMEOWNER PREPARATION

- Discuss the treatment program
  in advance with your pest control
  company so you fully understand what
  will be done and what you need to do.
- Carefully follow the instructions your are given about what items you are to remove from your building.
- Stay out of the treated building until it is cleared by your pest control company for reentry.
- If you are interested or concerned, you should ask your pest control company to show the records of how your building was aerated before it was cleared for reentry.
- You may wish to increase ventilation by opening doors and windows.
